Dear Mr. Gibson:

During the war, when I was at the Navy Department, I had many occasions to call on Lester Granger for advice and assistance. Shortly after I took over my present job last September, I again asked his advice, with a view to ascertaining the best way to proceed in setting up a meeting to discuss some of the problems facing the Armed Forces in the inter-racial field.

It had been my hope to have a meeting for this purpose last fall -- but the very heavy work of getting started with the task of unifying the Army, the Navy, and the Air Force has delayed such a meeting up until the present time.

Last week I had another opportunity to discuss this subject with Mr. Granger, and we agreed to call such a meeting for April 26. The meeting is to be held at 10:00 a.m. in the Conference Room of my office in the Pentagon Building.

A list of the persons invited to attend is attached, for your information. I hope that you will be able to be with us, for I know that you will have much to offer to what will be, I trust, a highly constructive meeting.

I have asked Mr. Granger to serve as Chairman of the meeting. Our present plans call for a series of discussions throughout the day, in which I will participate, along with the Secretaries of the Army, the Navy, and the Air Force.

More detailed arrangements will be outlined in a later letter. In the meantime, I would appreciate your letting me know whether or not you will be able to attend.
